## **FCC NATIONAL SECURITY ADVISORY**

REMINDER: COMMUNICATIONS EQUIPMENT AND SERVICES ON THE COVERED LIST POSE AN UNACCEPTABLE RISK TO NATIONAL SECURITY

WC Docket No. 18-89, ET Docket No. 21-232, EA Docket No. 21-233, ET Docket No. 24-136

The Federal Communications Commission issues this Advisory to reiterate that communications equipment and services on the FCC's Covered List have been determined to pose unacceptable risks to the national security of the United States and its citizens. Most of this equipment and services are closely tied to the foreign adversaries, like China, and can allow the CCP to surveil Americans, disrupt communications networks, and otherwise threaten U.S. national security. The use, importation, marketing, sale, provision, or receipt of covered equipment or services may threaten American national security, as may interconnection with such equipment or services. The FCC therefore strongly recommends that organizations and individuals currently using, or considering the purchase of, communications equipment and services review the Covered List and fully consider the risks posed by covered equipment and services.

The FCC's Covered List currently includes the following equipment and services:

- Telecommunications equipment produced by **Huawei Technologies Company**, including telecommunications or video surveillance services provided by such entity or using such equipment.
- Telecommunications equipment produced by **ZTE Corporation**, including telecommunications or video surveillance services provided by such entity or using such equipment.
- Video surveillance and telecommunications equipment produced by Hytera Communications Corporation, to the extent it is used for the purpose of public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, including telecommunications or video surveillance services provided by such entity or using such equipment.
- Video surveillance and telecommunications equipment produced by Hangzhou
   Hikvision Digital Technology Company, to the extent it is used for the purpose of

public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, including telecommunications or video surveillance services provided by such entity or using such equipment.

- Video surveillance and telecommunications equipment produced by **Dahua Technology Company**, to the extent it is used for the purpose of public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, including telecommunications or video surveillance services provided by such entity or using such equipment.
- Information security products, solutions, and services supplied, directly or indirectly, by **AO Kaspersky Lab** or any of its predecessors, successors, parents, subsidiaries, or affiliates.
- International telecommunications services provided by China Mobile International USA Inc. subject to section 214 of the Communications Act of 1934.
- Telecommunications services provided by **China Telecom (Americas) Corp.** subject to section 214 of the Communications Act of 1934.
- International telecommunications services provided by **Pacific Networks Corp** and its wholly-owned subsidiary **ComNet (USA) LLC** subject to section 214 of the Communications Act of 1934.
- International telecommunications services provided by China Unicom (Americas)
  Operations Limited subject to section 214 of the Communications Act of 1934.
- Cybersecurity and anti-virus software produced or provided by **Kaspersky Lab, Inc.** or any of its successors and assignees, including equipment with integrated Kaspersky Lab, Inc. (or any of its successors and assignees) cybersecurity or anti-virus software.

The Commission maintains an up-to-date version of the Covered List, which will reflect any additions or deletions from the List after issuance of this Advisory. The Covered List can be found on the Commission's website at https://www.fcc.gov/supplychain/coveredlist.

The FCC's Covered List determinations also apply to the subsidiaries and affiliates of entities that produce or provide the equipment or services identified on the Covered List. We therefore attach as Appendix A to this Advisory a list of subsidiaries and affiliates that entities named on the Covered List have identified to the Commission via filings in ET Docket No. 21-232 as producing covered communications equipment and services.<sup>2</sup> Appendix B includes all the
