THE OFFICE OF ECONOMICS AND ANALYTICS LAUNCHES A NEW AUCTION APPLICATION SYSTEM FOR SHORT-FORM (FCC FORM 175) APPLICATIONS FOR SPECTRUM AUCTIONS

The Office of Economics and Analytics (OEA) announces the launch of the Auction Application System (AAS), which auction applicants will use to submit short-form applications (FCC Form 175) for future Commission auctions. The AAS, which replaces the Commission's legacy Integrated Spectrum Auction System (ISAS), will allow auction applicants to submit their applications more efficiently and securely, consistent with the Commission's broad goals of increasing efficiency and modernizing the agency's processes in the digital age.¹

The AAS will be used first in the Commission's upcoming auction of licenses for spectrum in the AWS-3 bands (Auction 113). The window for filing FCC Form 175 short-form applications for Auction 113 will open on January 26, 2026, at 12:00 PM Eastern Time (ET). Until then, members of the public with an FCC Username associated with an FCC Registration Number (FRN) may access the Auction Application Portal (AAP) in the AAS to confirm their ability to log in and successfully authenticate to the system using multifactor authentication and set up the appropriate Auctions Permissions for their FRNs.²

Any party interested in applying to participate in Auction 113 is strongly encouraged to complete the steps necessary to enable it to log in to and access the AAP as soon as possible to allow for sufficient time to resolve any technical issues before the short-form application deadline. However, a party interested in applying to participate in Auction 113 will not be able to create an FCC Form 175 until the short-form application filing window opens.

The public search function in the Commission's legacy auction application system will be available until further notice at <https://auctionfiling.fcc.gov/form175/search175/index.htm>.

To access the AAP, an individual must have an FCC Username, and that FCC Username must be associated with an FRN in the Commission’s Registration System (CORES).³ An individual that has already registered an FCC Username account for use with another FCC system (e.g., Network Outage Reporting System (NORS) or Universal Licensing System (ULS)) may use that same FCC Username account to access the AAP.

Logging in to the AAP also requires the installation and use of Okta Verify® or Google Authenticator® for multifactor authentication.

Once an individual has taken all necessary steps to log in to the AAP, that individual must then be granted appropriate Auctions Permissions in the AAP by an Administrator for the potential applicant’s FRN in CORES in order for the individual to create, edit, and/or view an FCC Form 175 in the AAP.

The instructions and tutorial provide step-by-step guidance on how to register an FCC Username in CORES, how to obtain a new FRN in CORES, how to associate an FCC Username with a specific FRN in CORES to create an FCC Username account, how to set up Okta Verify® or Google Authenticator® for multifactor authentication, and how to obtain Auctions Permissions for an FRN in the AAP.
