On July 24, 2026, AirGSM Pte Ltd d/b/a Airalo (Airalo) filed an application for authority to provide global resale service in accordance with section 63.18(e)(2) of the Commission's rules. 47 CFR § 63.18(e)(2).

Airalo is a Singaporean entity that seeks authority to provide eSIMs for use in the United States. The following entities own a 10% percent or more equity and voting interest in Airalo: AirGSM Holdings, Inc., a Delaware company (100% direct equity and voting interest); Airplane Investment LP, a Delaware limited partnership (31.43% indirect equity and voting interest); Airplane Group Investment LP, a Delaware limited partnership (31.412% indirect equity and 31.12% voting interest); Airplane GP LLC, a Delaware limited liability company (0% indirect equity and 31.43% voting interest); CVC Capital Partners Asia VI (A) LP, a Jerseyan limited partnership (25.93% indirect equity and 31.43% voting); CVC Capital Partners Asia VI Limited, a Jerseyan entity (25.93% indirect equity and 31.43% voting); CVC Capital Partners PLC, a Jerseyan entity (25.93% indirect equity and 31.43% voting); Surge Ventures II, Limited, a Mauritius entity (15.15% indirect equity and voting interest); and Peak XV Partners Seed Fund I Limited (formerly Sequoia India & Southeast Asia), a Mauritius entity (11.57% indirect equity and voting interest).

Pursuant to Commission practice, the Application is being referred to the relevant Executive Branch agencies for their views on any national security, law enforcement, foreign policy, or trade policy concerns related to the foreign ownership of the entities at issue. Applicants state that, concurrent with filing the Application, they submitted directly to the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (Committee) responses to the Committee's standard questions.
