NOTICE OF PROPOSED RULE MAKING

By the Chief, Allocations Branch:

- 1. The Commission has before it the petition for rule making filed by Annette G. Thompson ("petitioner"), proposing the allotment of Channel 295C3 to Franklin, Louisiana, as the community's second local FM service. Petitioner states she will apply for Channel 295C3, if allotted.
- 2. We believe petitioner's proposal warrants consideration since it could provide Franklin with an additional FM service. Channel 295C3 can be allotted to Franklin in compliance with the Commission's minimum distance separation requirements without the imposition of a site

At the request of South Louisiana Broadcasters we issued a Notice in MM Docket No. 96-36 seeking the allotment of Channel 295C3 at Franklin, Louisiana. See Notice of Proposed Rule Making, 11 FCC Rcd 2981 (1996). In response to that Notice, Bob Holbrook filed a counterproposal requesting the allotment of Channel 295C3 at White Castle, Louisiana, in lieu of its allotment at Franklin, Louisiana. South Louisiana Broadcasters' request was dismissed since they failed to file comments indicating their continuing interest in the allotment of 295C3 at Franklin. Bob Holbrook's counterproposal was not accepted for consideration. We found his counterproposal constituted an exparte presentation since a copy of his counterproposal was not served on South Louisiana Broadcasters pursuant to Section 1.420 of the Commission's rules and paragraph 7 of the Notice's Appendix. See Report and Order in Docket No. 96-36 (adopted July 19, 1996). Ms. Thompson's petition for rule making was filed after the close of the comment period in that proceeding, therefore, based on the action taken in MM Docket No. 96-36 we will issue a new Notice seeking the allotment of Channel 295C3 at Franklin, Louisiana. as advanced by Ms. Thompson.

- 4. In particular, we note that a showing of continuing interest is required by paragraph 2 of the Appendix before a channel will be allotted.
- 5. Interested parties may file comments on or before October 7, 1996, and reply comments on or before October 22, 1996, and are advised to read the Appendix for the proper procedures. ² The coordinates for Channel 295C3 at Franklin are North Latitude 29-47-42 and West Longitude 91-30-12. Petitioner suggested that the allotment could be made at coordinates North Latitude 29-48-55 and West Longitude 91-35-10 with a site restriction of 8.3 kilometers (5.2 miles) west. Consistent with Commission policy, we will advance the less restrictive site for the allotment of Channel 295C3 at Franklin.

decided and such decision is no longer subject to reconsideration by the Commission or review by any court. An <u>ex parte</u> presentation is not prohibited if specifically requested by the Commission or staff for the clarification or adduction of evidence or resolution of issues in the proceeding. However, any new written information elicited from such a request or a summary of any new oral information shall be served by the person making the presentation upon the other parties to the proceeding unless the Commission specifically waives this service requirement. Any comment which has not been served on the petitioner constitutes an <u>ex parte</u> presentation and shall not be considered in the proceeding. Any reply comment which has not been served on the person(s) who filed the comment, to which the reply is directed, constitutes an <u>ex parte</u> presentation and shall not be considered in the proceeding.

APPENDIX

- 1. Pursuant to authority found in Sections 4(i), 5(c)(1), 303(g) and (r), and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS PROPOSED TO AMEND the FM Table of Allotments, Section 73.202(b) of the Commission's Rules and Regulations, as set forth in the Notice of Proposed Rule Making to which this Appendix is attached.
- 2. Showings Required. Comments are invited on the proposal(s) discussed in the Notice of Proposed Rule Making to which this Appendix is attached. Proponent(s) will be expected to answer whatever questions are presented in initial comments. The proponent of a proposed allotment is also expected to file comments even if it only resubmits or incorporates by reference its former pleadings. It should also restate its present intention to apply for the channel if it is allotted and, if authorized, to build a station promptly. Failure to file may lead to denial of the request.
- 3. <u>Cut-off protection</u>. The following procedures will govern the consideration of filings in this proceeding.
- (a) Counterproposals advanced in this proceeding itself will be considered, if advanced in initial comments, so that parties may comment on them in reply comments. They will not be considered if advanced in reply comments. (See Section 1.420(d) of the Commission's Rules).
- (b) With respect to petitions for rule making which conflict with the proposals in this Notice, they will be considered as comments in the proceeding, and Public Notice to this effect will be given as long as they are filed before the date for filing initial comments herein. If they are filed later than that, they will not be considered in connection with the decision in this docket.
- (c) The filing of a counterproposal may lead the Commission to allot a different channel than was requested for any of the communities involved.
- 4. Comments and Reply Comments: Service. Pursuant to applicable procedures set out in Sections 1.415 and 1.420 of the Commission's Rules and Regulations, interested parties may file comments and reply comments on or before the dates set forth in the Notice of Proposed Rule Making to which this Appendix is attached. All submissions by parties to this proceeding or by persons acting on behalf of such parties must be made in written comments, reply comments, or other appropriate pleadings. Comments shall be served on the petitioner by the person filing the comments. Reply comments shall be served on the person(s) who filed comments to which the reply is directed. Such comments and reply comments shall be

accompanied by a certificate of service. (See Section 1.420(a), (b) and (c) of the Commission's Rules.) Comments should be filed with the Secretary, Federal Communications Commission, Washington, D.C. 20554.

- 5. <u>Number of Copies</u>. In accordance with the provisions of Section 1.420 of the Commission's Rules and Regulations, an original and four copies of all comments, reply comments, pleadings, briefs, or other documents shall be furnished the Commission.
- 6. <u>Public Inspection of Filings</u>. All filings made in this proceeding will be available for examination by interested parties during regular business hours in the Commission's Public Reference Room at its headquarters, 1919 M Street, N.W., Washington, D.C.
