

By the Chief, Wireless Telecommunications Bureau:

By authority delegated in Section 0.331 of the Commission's Rules, 47 C.F.R. § 0.331, Part 22 of the Commission's Rules governing the Public Mobile Services is hereby amended to make certain non-substantive editorial revisions. These amendments, detailed in Appendices A and B attached hereto, are necessary to correct several inadvertant errors and inconsistencies in these rules as they currently appear in the Code of Federal Regulations.

APPENDIX A

Description of Non-substantive Editorial Revisions of Part 22 of the Commission's Rules

1. **Typographical error in definition of "frequency".** An extra word, "of" is removed.
2. **Erroneous references to obsolete application form.** In Sections 22.105 and 22.953(a)(4), references to old FCC Form 401 are corrected to refer to the current form, FCC Form 600, which replaced FCC Form 401.
3. **Omitted standard forms.** In Table B-1 in Section 22.105, which lists the standard forms used in the Public Mobile Services, FCC Forms 464 and 464-A are added. These existing forms were unintentionally overlooked when this rule was initially added.
4. **Correction of address in discontinuance of operation rule.** This rule is amended to reflect the current name of the FCC division where authorizations must be submitted for cancellation when station operation is discontinued.
5. **Missing frequency tolerance table.** Table C-1 of Section 22.355 is restored after being inadvertently removed. When initially added, this table was erroneously associated with Section 22.357 instead of Section 22.355. Later, when Section 22.357 was amended, it resulted in the unintended removal of Table C-1.
6. **Missing cross reference.** In Section 22.357, the air-ground emission mask rule (Section 22.861) is cross-referenced, in addition to the paging and cellular emission masks.
7. **Typographical error and organizational change in the quiet zone rule.** In Section 22.369, paragraph (c)(2), the symbol "†" is corrected to "π". Additionally, in paragraph (c)(3) of that section, the reference to the "Chief, Field Operations Bureau" is changed to "Chief, Compliance and Information Bureau".
8. **Erroneous reference in developmental authorization rule.** In Section 22.409(h)(2), the reference to paragraph (e) is corrected to refer instead to paragraph (f).
9. **Deletion of Note about limitation of the FCC's former mainframe computer.** The Note following Section 22.507 concerned a limitation of the software associated with the FCC's mainframe computer, which has since been decommissioned.
10. **Erroneous reference in Section 22.509.** In Section 22.509, paragraph (c) is corrected to refer to Section 22.131(c)(4)(ii) of the Commission's Rules, rather than Section 22.13(c)(4)(ii).

11. **Erroneous center frequency.** In the frequency listing in Section 22.621, under the heading "Public Mobile Pool" and sub-heading "(12.5 kHz bandwidth)", in the second row, second column, the number "959.85625" is changed to "959.86875". This was a typographical error.

APPENDIX B

Part 22 of Chapter I of Title 47 of the Code of Federal Regulations is amended as follows:

Part 22 - Public Mobile Services

12. The authority citation for Part 22 continues to read as follows:

Authority: Sections 4, 303, 309 and 332, 48 Stat. 1066, 1082, as amended, 47 U.S.C. 154, 303, 309 and 332, unless otherwise noted.

13. In Section 22.99, in the definition for the term "Frequency", remove the third occurrence of the word "of".

14. In Section 22.105, revise the introductory text and Table B-1 of paragraph (c), to read as follows:

§ 22.105 Written applications, standard forms, microfiche, magnetic disks.

Except for authorizations granted under the emergency conditions set forth in § 308 of the Communications Act of 1934, as amended (47 U.S.C. 308), the FCC may grant authorizations only upon written application (FCC Form 600) received by it. * * *

15. In Section 22.317, remove the words "Mobile Services Division, Common Carrier Bureau", and add, in their place, the words "Commercial Wireless Division, Wireless Telecommunications Bureau".

16. In Section 22.355, revise the introductory text and add Table C-1, as follows:

§ 22.355 Frequency tolerance.

Except as otherwise provided in this part, the carrier frequency of each transmitter in the Public Mobile Services must be maintained within the tolerances given in Table C-1 of this section.

Table C-1 - Frequency Tolerance for Transmitters in the Public Mobile Services

17. Revise the text of Section 22.357 to read as follows:

§ 22.357 Emission types.

Any authorized station in the Public Mobile Services may transmit any emission type provided that the resulting emission complies with the appropriate emission mask. See §§ 22.359, 22.861 and 22.917.

18. In Section 22.369, paragraph (c)(2), remove the symbol "†" and add, in its place, the Greek letter "π".

19. In Section 22.369, paragraph (c)(3), remove the words "Chief, Field Operations Bureau" and add, in their place, the words "Chief, Compliance and Information Bureau".

20. In Section 22.409, paragraph (h)(2), remove the words "paragraph (e)" and add, in their place, the words "paragraph (f)".

21. Remove the NOTE following Section 22.507.

22. In Section 22.621, in the table in the introductory text, under the heading "Public Mobile Pool", under the heading "(12.5 kHz bandwidth)", in the second row of the second column, remove the number "959.85625" (second occurrence) and add, in its place, the number "959.86875".

23. In Section 22.509, paragraph (c), remove the words "See § 22.13(c)(4)(ii)" and add, in their place, the words "See § 22.131(c)(4)(ii)."
