**Pleading Cycle Established for Waivers of Down Payment Rules in the Broadband  
Personal Communication Services C Block, 900 MHz Specialized Mobile Radio, and  
Multipoint Distribution Service Auctions**

*Waivers Requested by 8 Applicants in C Block, 8 Applicants in 900 MHz SMR, and 1  
Applicant in MDS*

Comment/Opposition Due Date: October 28, 1996  
Reply Comment Due Date: November 1, 1996

The Wireless Telecommunications Bureau and the Mass Media Bureau have received several requests for waiver of down payment requirements in connection with three recent auctions: Broadband PCS C Block, 900 MHz SMR, and MDS. All parties seeking waiver are winning bidders who missed the deadline for the second down payment on licenses won at auction. Comment is solicited on all aspects of each specific waiver requests presented below in this Notice. Comments or oppositions should specifically reference this Public Notice (DA 96-1692) and the specific waiver request or requests and must be filed on or before October 28, 1996. Reply comments may be filed on or before November 1, 1996. ## I. Broadband PCS C Block Auction

The following parties are small business winning bidders who were entitled to pay their 10% down payment in two separate 5% payments pursuant to 47 C.F.R. § 24.711(a)(2). By Public Notice released on September 17, 1996, the Wireless Telecommunications Bureau notified winning bidders that the Commission would be granting C block licenses, and that the second half of the down payment would be due on September 24.<sup>1</sup> Of the following eight parties, six submitted late payments and two have not made payment.

## II. 900 MHz SMR

The following parties are small business winning bidders, who were entitled to pay their 10% down payment in two separate 5% payments pursuant to 47 C.F.R. § 90.811. By Public Notice released on June 28, 1996, the Wireless Telecommunications Bureau notified winning bidders that the Commission would be granting the 900 MHz SMR licenses, and that the second half of the down payment would be due on July 8, 1996.<sup>2</sup> All of the parties listed below submitted the second half of their down payments late.
