By the Chief, Allocations Branch:

1. Before the Commission for consideration is the Notice of Proposed Rule Making, (Notice), 12 FCC Rcd 1951 (1997), issued in response to a petition for rule making filed by Fred R. Morton, Jr., ("petitioner") proposing the allotment of Channel 268A to Greenwood, Arkansas, as that community's second local FM transmission service. Petitioner filed supporting comments in response to the Notice. No other comments were received.¹

2. In view of the interest expressed in providing a second local FM transmission service to Greenwood, Arkansas, we will allot Channel 268A to that community, as requested.

3. As stated in the *Notice*, Channel 268A can be allotted to the Greenwood consistent with the minimum distance separation requirements of Section 73.207(b)(1) of the Commission's Rules, without a site restriction, utilizing the city reference location at coordinates 35-12-54 and 94-15-30.

4. Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective August 11, 1997, the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, IS AMENDED with respect to Greenwood, Arkansas, as follows:
