Parties seeking special relief are advised that such requests must be initiated through the special relief provisions of Section 76.7 of the Rules. Many of these filings are subject to the pleading cycle rules set forth in Section 76.7, while others have their own pleading cycle relative to the particular rule involved.

Files containing these petitions can be reviewed in the Commissions Reference Information Center, CY-Level, 445 12th Street, SW Washington, DC 20554. The letter code following a CSR Number refers to the particular subject of the petition. Those currently in use are: A - ADI/DMA; M - must carry; E - effective competition; C - retransmission consent; P - program access; R - rate regulation; F - rate freeze; L - commercial leased access; Z - technical; S - significantly viewed; N - nonduplication/syndicated exclusivity/sports deletion; D - small system definition; O - otard; and X - cross ownership. If no letter appears after the CSR number, the petition is considered to be in the miscellaneous category. Show cause petitions do not have letter codes.

It is requested that all responses or statements refer to the CSR number assigned to the petition.
