ERRATUM

By the Assistant Chief, Audio Division:

1. The Audio Division issued a *Report and Order* (“*R&O*”) in the above-docketed cases on March 14, 2003.¹ The *R&O* inadvertently gave incorrect coordinates for the proposed allotments in two of the proceedings, the allotment of Channel 282A at Santa Anna, Texas (MM Docket No. 01-220) and the allotment of Channel 283C2 at Hamlin, Texas (MM Docket No. 01-285).

2. Accordingly, sections E. and L. of the first paragraph of the *Report and Order* are revised to read as follows:

E. MM Docket No. 01-220; RM-10239

Action: At the request of Jeraldine Anderson, we are allotting Channel 282A at Santa Anna, Texas, as the community’s second local FM transmission service.²

Coordinates: The reference coordinates for Channel 282A at Santa Anna are 31-42-15 NL and 99-20-23 West Longitude.

Additional Information: This allotment requires a site restriction of 4.3 km (2.7 miles) south of Santa Anna at the coordinates indicated above. Because the reference coordinates are within 320 kilometers (199 miles) of the U.S.-Mexico border, this change to the FM Table of Allotments is contingent upon concurrence of the Mexican Government in the allotment.

Action: At the request of Linda Crawford, we are allotting Channel 283C2 at Hamlin, Texas, as the community’s second local FM transmission service.³

Coordinates: The reference coordinates for Channel 283C2 at Hamlin are 32-51-53 NL and 100-13-01 West Longitude.

Additional Information: This allotment requires a site restriction of 8.7 km (5.4 miles) west of Hamlin at the coordinates indicated above.
