Certain pleadings must be filed electronically (electronic mail or facsimile), by hand delivery, or by overnight delivery service other than U.S. Postal Service Express and Priority Mail.

The Commission may return any of the applications, if upon further examination, it is determined they are defective or not in conformance with the Commission's rules and regulations.

Final action will not be taken on applications requesting an Assignment of Authorization or Transfer of Control of FCC licenses earlier than 31 days following the date of the pubic notice, except for applications not requiring a 30-day notice period (See Section 309(c) of the Communications Act, as amended) and for applications subject to streamlined approval procedures (See Section 1.948(j)(2) of the Commission's rules). Final action will not be taken on applications involving Assignment of Authorization or Transfer of Control of FCC licenses that are subject to streamlined approval procedures, de facto transfer leases, including subleases, and transfer of control or assignment of existing lease rights earlier than 15 days following the date of the public notice, except for applications not requiring a 14-day notice period (See Section 309(c) of the Communications Act, as amended).
