## CONSUMER ADVISORY COMMITTEE TO MEET FRIDAY, JUNE 10, 2005 *First Meeting of Newly Rechartered Committee*

Washington, DC – The Consumer Advisory Committee (CAC) will hold its next meeting on Friday, June 10, from 8:30 A.M. to 4:00 P.M. at the Commission's Headquarters Building, Room TW-C305, 445 12<sup>th</sup> Street, SW, Washington, DC 20554. The meeting is open to the public.

The agenda includes briefings regarding CAC goals and objectives, the Committee's bylaws, the responsibilities of CAC members, an overview of the FCC's processes and procedures, the role of the working groups and subcommittees, and issues pending before the FCC of interest to consumers. The Tentative Agenda for the meeting is attached.

The CAC is chaired by Shirley Rooker, President of Call For Action, and is composed of 55 members representing many of the FCC's constituencies. The expertise and diversity of the members provide a balanced point of view as required by the Federal Advisory Committee Act.

The Committee is organized under, and operates in accordance with, the provisions of the Federal Advisory Committee Act, 5 U.S.C., App. 2 (1988).
