Certain pleadings must be filed electronically (electronic mail or facsimile), by hand delivery, or by overnight delivery service other than U.S. Postal Service Express and Priority Mail.

- \* When the search is completed, the application will be listed by file number on the screen;
- \* Click on the file number (in hypertext) to view the application and attachments.
