Brewer Broadcasting of Cleveland, LLC licensee of WAYA(FM), Spring City, Tennessee, and J.L. Brewer Broadcasting, LLC, licensee of Station WMPZ(FM), Ringgold, Georgia (collectively, "Brewer"), in MB Docket No. 05-282, RM-11229, on December 5, 2005, as amended in Joint Reply Comments submitted by

Brewer and Woman's World Broadcasting, Inc., on December 20, 2005, as a proposed resolution of the conflicting proposals in the proceeding: The counterproponents propose a change of community for WAYA(FM), requiring the deletion of Channel 230C3 at Spring City, Tennessee, and the addition of Channel 230C3 at Decatur, Tennessee. The proposed coordinates of Channel 230C3 at Decatur are 35-27-30 NL and 84-42-18 WL. The counterproponents request the modification of the license for Station WAYA(FM) to specify operation on Channel 230C3 at Decatur, Tennessee.

To accommodate that change, the counterproponents also propose a change of community for WMPZ(FM), requiring the deletion of Channel 229A at Ringold, Georgia, and the addition of Channel 228A at Harrison, Tennessee. The proposed coordinates of Channel 228A at Harrison are: 35-07-06 NL and 85-14-29 WL. The counterproponents request the modification of the license for Station WMPZ(FM) to specify operation on Channel 228A at Harrison, Tennessee.

To further accommodate the proposed allotment changes, the counterproponents request that Station WLJA-FM, Ellijay, Georgia, be required to change from Channel 228A to Channel 266A, and that the Commission issue an Order to Show Cause to Tri-State Communications, Inc., the licensee of Station WLJA-FM. Under this proposal, Station WLJA-FM would remain at its existing coordinates: 34-42-59 NL and 84-30-50 WL.

Finally, to accommodate all of these changes, the counterproponents propose a consensual downgrade for Station WROQ(FM), Anderson, South Carolina, from Channel 266C0 to Channel 266C1. Station WROQ(FM) would remain at its existing coordinates: 34-38-51 NL and 82-16-13 WL.
