**STREAMLINED INTERNATIONAL APPLICATIONS ACCEPTED FOR FILING
SECTION 214 APPLICATIONS (47 C.F.R. § 63.18); SECTION 310(B)(4) REQUESTS**

Unless otherwise specified, the following procedures apply to the applications listed below:

The international Section 214 applications listed below have been found, upon initial review, to be acceptable for filing and subject to the streamlined processing procedures set forth in Section 63.12 of the Commission's rules, 47 C.F.R. § 63.12. These applications are for authority under Section 214 of the Communications Act, 47 U.S.C. § 214, (a) to transfer control of an authorized carrier or to assign a carrier's existing authorization; and/or (b) to become a facilities-based international common carrier; and/or (c) to become a resale-based international common carrier.

Pursuant to Section 63.12 of the rules, these Section 214 applications will be granted 14 days after the date of this public notice (see 47 C.F.R. § 1.4 regarding computation of time), and the applicant may commence operations on the 15th day, unless the Commission has informed the applicant in writing, within 14 days after the date of this public notice, that the application, on further examination, has been deemed ineligible for streamlined processing.

Communications between outside parties and Commission staff concerning these applications are permitted subject to the Commission's rules for "permit-but-disclose proceedings." See 47 C.F.R. § 1.1206. An application can be removed from streamlined processing only in the sound discretion of Commission staff. The filing of comments or a petition to deny will not necessarily result in an application being deemed ineligible for streamlined processing.

The petitions for declaratory ruling listed below are for authority under Section 310(b)(4) of the Communications Act, 47 U.S.C. § 310(b)(4), to exceed the 25 percent foreign ownership benchmark applicable to common carrier radio licensees. The requested rulings will be granted 14 days after the date of this public notice, effective the next day, unless the application is formally opposed or the Commission has informed the applicant in writing, within 14 days of the date of this public notice, that the application, on further examination, has been deemed ineligible for streamlined processing. For this purpose, a formal opposition shall be sufficient only if it is received by the Commission and by the applicant within 14 days of the date of this public notice and its caption and text make it unmistakably clear that it is intended to be a formal opposition.

Application for consent to assign certain assets relating to the large business customer enterprise business of Acceris Management and Acquisition LLC (Acceris) to First Communications, LLC (First Communications) pursuant to an Asset Purchase Agreement (Agreement) dated July 11, 2006. The assets being assigned are geographically located in all the contiguous 48 states, plus Hawaii and the District of Columbia, but not Alaska, and include certain customer accounts. Upon consummation, First Communications will provide service to the Acceris customers being acquired pursuant to its existing international section 214 authorization, ITC-95-622 (see also ITC-ASG-20011001-00509), and Acceris will retain its international section 214 authorization, ITC-214-20011010-00517 (see also ITC-ASG-20050701-00260) to provide service apart from the business acquired by First Communications. The following 3 entities hold 10 percent or greater direct ownership interests in First Communications: McKinley Communications, LLC (McKinley) (51%); First Energy Corp. (31.85%); and Boich Investment Group, Ltd. (Boich) (17.15%). Marbel Investments, LLC (Marbel), holds an 80 percent controlling ownership interest in McKinley. Marbel is owned and controlled in equal shares by four U.S. citizens. Wayne Boich, Sr., a U.S. citizen, holds 100 percent ownership interest in Boich. There are no other individuals or entities with a ten percent-or-greater direct or indirect interest in First Communications.
