Because of recent events in Washington, D.C., resulting in the disruption of regular mail delivery and of the processing of other deliveries, the Commission released, on November 29, 2001, an Order temporarily amending certain procedural rules on an emergency basis. See "Implementation of Interim Electronic Filing Procedures for certain Commission filings", FCC 01-345, Order, (rel. November 29, 2001). Certain pleadings must be filed electronically (electronic mail or facsimile), by hand delivery, or by overnight delivery service other than U.S. Postal Service Express and Priority Mail.

Below is a listing of applications, subject to applicable pre-grant notice and petition procedures, that upon initial review were accepted for filing. The Commission may return any of the applications, if upon further examination, it is determined they are defective or not in conformance with the Commission's rules and regulations.

Final action will not be taken on applications involving an Assignment of Authorization or Transfer of Control of FCC licenses, de facto transfer leases, including subleases, or transfer of control or assignment of existing lease rights, or designated entity reportable eligibility event earlier than 15 days following the date of the public notice, except for applications not requiring a prior notice period.

- * On the Application Search Screen, select the Search Type for "Transfers and Assignments" and click on the "Continue" button;
- * Type the application's 10-digit file number into the "File Number:" field on the Application Search screen;
- * Scroll to the bottom of the page and click the "Search" button;
- * When the search is completed, the application will be listed by file number on the screen;
- * Click on the file number (in hypertext) to view the application and attachments.
