Application for 325(c) permit, filed by Frecuencia Modulada de Noroeste (MVS de Juarez, S.A. de C.V.), to deliver programming to FM broadcast station XHOCL, 99.3 MHz, Tijuana, Mexico. The holder of the concession for XHOCL is Xetra Comunicaciones, S.A. de C.V. The applicant proposes to provide programming which will include news, information and entertainment in Spanish for up to 24 hours per day, seven days per week, except for that airtime retained by the concession holder to comply with the requirements of Mexican law.

Petitions to deny this application must reference the file number associated with the 325(c) application and be on file no later than 30 days from the date of the notice accepting this Application for filing.
