

Annual Report of Spectrum Five, LLC

On November 29, 2006, the Commission granted Spectrum Five's Petition for Declaratory Ruling for authority to access the United States from two direct broadcast satellites at the 114.5° W.L. orbital location.¹ That order requires Spectrum Five, every June 30, to submit annual progress reports illustrating the steps it has taken toward meeting its milestones consistent with the reporting requirements of other satellite operators set forth in Section 25.210 of the FCC's rules. Spectrum Five hereby submits the required annual report with information current as of May 31, 2008.

Spectrum Five's first milestone requirement, to complete contracting for construction of the satellites, was due November 29, 2007. On November 28, 2007, Spectrum Five filed with the Commission a copy of the contract between Spectrum Five and Space Systems/Loral, Inc. for construction of Spectrum Five's two satellites.² Both parties are progressing towards Spectrum Five's next milestone, completion of critical design review.
