NOTICE OF VIOLATION

Released: July 20, 2009

By the District Director, Chicago Office, Northeast Region, Enforcement Bureau:

1. This is a Notice of Violation (“Notice”) issued pursuant to Section 1.89 of the Commission’s Rules¹ to Paducah & Louisville Railway, Inc., the owner of antenna structure # 1201042.
2. On July 7, 2009, an agent of the Commission’s Chicago Office inspected antenna structure # 1201042, located at the 8th Street P&L Tracks, Central City, KY, and observed the following violation:

47 C.F.R. § 17.4(g): “. . . the Antenna Structure Registration Number must be displayed in a conspicuous place so that it is readily visible near the base of the antenna structure” At the time of inspection, no Antenna Structure Registration Number was readily visible near the base of the tower.
3. Pursuant to Section 403 of the Communications Act of 1934, as amended,² and Section 1.89 of the Commission's Rules, Paducah & Louisville Railway, Inc. must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response must fully explain each violation, must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and should include a time line for completion of pending corrective action(s). The response must be complete in itself and signed by a principal or officer of Paducah & Louisville Railway, Inc. All replies and documentation sent in response to this Notice should be marked with the File No. and NOV No. specified above, and mailed to the following address:

4. This Notice shall be sent to Paducah & Louisville Railway, Inc., at its address of record.
5. Any false statement made knowingly and willfully in reply to this Notice is punishable by fine or imprisonment under Title 18 of the U.S. Code.⁴
