ATT20090827S.1	AT&T Southeast is receiving remuneration from the USF and negotiates a plan for the allocated budget with the State Public Service Commission each year to benefit rural residents in its approved service areas. Under this plan, Copper Facilities which feed an area in Cynthiana, Kentucky along State Highway 346 from Ammerman Pike to Mill Creek Road; along Rocky Springs Road a distance of 0.6 miles from Highway 346; and along Ammerman Pike from Highway 346 to State Highway 32 W, will be replaced with fiber fed digital loop carrier (DLC).
