Dear Chairman Genachowski, and Commissioners McDowell, Baker and Clyburn,

I write today to draw your attention to concerns raised by multiple small telecommunications companies in rural Oregon regarding Universal Service Fund (USF) audits. I ask that in determining the future of USF audits, the Commission take into consideration the concerns of rural telecommunications providers.


I commend the Federal Communications Commission (FCC) for seeking to end fraud, waste and abuse of the Universal Service Fund. Every telecommunications customer who pays into this fund expects that their contributions be used for their intended purposes: to aid low-income customers, rural customers, schools, libraries, and rural medical centers. Instances where USF funds are not used appropriately need to be investigated, remedied and appropriate penalties imposed in accordance with the law.

While I support the use of audits to ensure appropriate use of USF funds, I have heard from rural telecommunications providers in Oregon that the audit process can create undue hardship for their business and customers. I have also heard concerns that some of the auditors lack experience and knowledge of the telecommunications industry, making it difficult for the auditor to conduct a full and fair review of the organization as they can struggle to discern the difference between standard industry practices and inappropriate actions of a company. The small telecommunications companies in my state depend on the USF and want to see the funds used wisely, including the most efficient audits possible.

I commend the FCC for inviting public comment "on ways to further strengthen management, administration, and oversight of the USF... define more clearly the goals of the USF ... identify any additional quantifiable performance measures" and "comment on whether, and if so, to what extent the Commission's oversight of the USF can be improved." I know that some of my constituents submitted comments and offered to meet with FCC staff to discuss their concerns with the audit process among other issues. I encourage the FCC staff to take advantage of the opportunity to hear from small telecommunications providers who are working to comply with these requirements while providing service to customers in rural communities. I believe their insight may help the FCC improve the process and save taxpayer dollars while continuing to ensure USF dollars are spent appropriately.

Thank you in advance for your consideration of this matter. I look forward to working with you to ensure that USF audits are conducted in a manner that is fair to small and rural telecom companies, while also safeguarding taxpayer dollars.
