ATT20090803S.1	At 6.7 KFT from Central Office, new Digital Loop Electronics (DLE) equipment and a cross box will replace Central Office fed copper. All circuits within range will be fed by new cross box at 607 Denver Drive and existing cross boxes in the area (PED 61-2 Highway 5 and PED 38.2 Highway 22) will be back fed from new DLE equipment. Central Office fed copper is in conflict with the TDOT I-69 interstate project and is to be removed.	Union City, TN
