AT&T Midwest is consolidating two pairs of Signal Transfer Points (STPs) in the AT&T Midwest Region. Carriers who connect with AT&T in the AT&T Midwest Region in either LATA 352 or LATA 322 using A and B Links will need to move their links according to the tables. Prior to the issuance of ASRs, AT&T Midwest will provide a new CLLI code or Facilities Signaling Point of Interconnection (FSPOI) within the same LATA in which the Carrier presently connects.
