Reclassification of FM Facilities in Puerto Rico and the Virgin Islands  
Re: BC Docket 80-90; BC Docket 81-421; MMB ORDER of May 10, 1984

The new rules adopted in BC Docket 80-90; BC Docket 81-421; and by order of the Chief, Mass Media Bureau on May 10, 1984 allow increased antenna heights for FM class 'A', 'B1' and 'B' facilities in Puerto Rico and the Virgin Islands. These actions also specify minimum values of ERP for each of the classes and combination ERP-HAAT values which define the location of the 60 dBu contour. Existing class 'B' facilities have until March 1, 1987 to meet the minimums specified in BC Docket 80-90 or be reclassified to a lower class. This notice contains a list of all the FM facilities in Puerto Rico and the Virgin Islands and includes the existing class and new classification which they will receive in March 1987 if there is no upgrade.

This list is arranged by channel number and then city, and contains license, construction permit and application records in the FM Engineering Data Base as of June 1, 1984. The facility class shown is based on the current authorization (license or CP). No attempt has been made to correlate applications, which upgrade facilities, with license or CP records on the list.

Noncommercial educational facilities will be reclassified on March 1, 1987 as defined in Section 73.506(a)(3). The separation distance requirements between noncommercial educational facilities on channels 218, 219, and 220 or facilities separated in frequency by 10.6 or 10.8 MHz (53 or 54 channels) and allotments or assignments on the non-reserved channels will be based on these reclassifications and the distance obtained from Table A, B, or C (Section 73.207) as appropriate. For other non-commercial educational facilities, the reclassification is for administrative purposes only.

The list is published for information purposes only. The inclusion or exclusion of any FM facility does not reflect a determination of any eventual class designation. The inadvertent exclusion of any FM facility from this list will not be grounds for extension of the March 1, 1987 date.
