NOTICE OF VIOLATION

Released: April 30, 2010

By the District Director, Philadelphia Office, Northeast Region, Enforcement Bureau:

- 1. This is a Notice of Violation ("Notice") issued pursuant to Section 1.89 of the Commission's Rules¹ to WESTPANET, Inc., operator of a cable system in Clarendon, Pennsylvania.
- 2. On April 21, 2010, an agent of the Commission's Philadelphia Office monitored WESTPANET's cable television system in the Clarendon, Pennsylvania area, and observed the following violation:

47 C.F.R. § 76.605(a)(12): "As an exception to the general provision requiring measurements to be made at subscriber terminals, and without regard to the type of signals carried by the cable television system, signal leakage from a cable television system shall be measured in accordance with the procedures outlined in 76.609(h) and shall be limited as follows: Over 54 MHz up to and including 216 MHz..... 20 micro-volts per meter, measured at 3 meters." At the time of the inspection, the agent measured signal leakage in excess of $20~\mu\text{V/m}$ on the frequency of 121.2625~MHz at the following locations:

The response must be complete in itself and signed by a principal or officer of the WESTPANET, Inc. Any false statement made knowingly and willfully in reply to this Notice is punishable by fine or imprisonment under Title 18 of the U.S. Code.⁴
