ATT20100519S.1	AT&T West – CIC 5233 was established in the 1990's in order to route Toll Free traffic on the AT&T West Official Company Service network (OCS). The CIC was established in all Pacific end offices and tandems for termination into AT&T West's business offices and repair centers. The CIC was also built in many CLEC/ILEC switches that homed off of AT&T Tandems. As AT&T West completes the migration of this traffic to its LD affiliate, CIC 5233 is being decommissioned for this service and should be removed from the CLEC/ILEC switches. This CIC will be used in the future in another application.	ALL  California and Nevada
