WHITE HOUSE, FCC AND COMMERCE TO HOST AMERICANS WITH DISABILITIES ACT (ADA) ANNIVERSARY EVENT, MONDAY, JULY 19.

WASHINGTON -- The White House, in partnership with the Federal Communications Commission and the Department of Commerce, will host an event Monday, July 19, to commemorate and celebrate the 20th anniversary of the Americans with Disabilities Act and highlight technologies developed to empower the daily lives of Americans with disabilities.

A technology showcase is scheduled from 11 a.m. to 3:00 p.m. in the main foyer of the Commerce Department, where exhibitors have been invited to demonstrate their technologies.

From 1 p.m. to 2 p.m. a program in Commerce's Auditorium will include the launch of the FCC's new Accessibility and Innovation Forum, presentation of an original video chronicling personal histories about the impact of technology on the lives of people with disabilities, a performance by Gallaudet University students, and a reception. Both the showcase and the program are free and open to the public.

Sign language interpreters and computer aided real-time transcription (CART) will be provided. Other accommodations for people with disabilities are available upon request. Include a description of the accommodation you will need and tell us how to contact you if we need more information. Make your request as early as possible, but no later than Thursday, July 15, 2010.
