NOTICE OF VIOLATION

Released: July 23, 2010

By the District Director, Chicago Office, Northeast Region, Enforcement Bureau:

- 1. This is a Notice of Violation ("Notice") issued pursuant to Section 1.89 of the Commission's Rules¹ to Chippewa County, owner of antenna structure # 1215570 in Eagle Point Township, Wisconsin.
- 2. On July 15, 2010, an agent of the Commission's Chicago Office conducted an investigation of antenna structure # 1215570 and observed the following violation:
 - 47 C.F.R. § 17.4 (g): "Except as described in paragraph (h) of this Section, the Antenna Structure Registration Number must be displayed in a conspicuous place so that it is readily visible near the base of the antenna structure. Materials used to display the Antenna Structure Registration Number must be weather-resistant and of sufficient size to be easily seen at the base of the antenna structure." Chippewa County failed to post the Antenna Structure Registration Number 1215570.
- 3. Pursuant to Section 403 of the Communications Act of 1934, as amended,² and Section 1.89 of the Commission's Rules, Chippewa County must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response must fully explain each violation, must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and should include a time line for completion of pending corrective action(s). The response must be complete in itself and signed by a principal or officer of Chippewa County. All replies and documentation sent in response to this Notice should be marked with the File No. and NOV No. specified above, and mailed to the following address:
