NOTICE OF VIOLATION

Released: September 8, 2011

By the District Director, San Diego Office, Western Region, Enforcement Bureau:

- 1. This is a Notice of Violation ("Notice") issued pursuant to Section 1.89 of the Commission's Rules, to El Camino Communications, LLC ("El Camino"), licensee of radio station KKNS, licensed to serve Corrales, New Mexico. This Notice may be combined with a further action, if further action is warranted.²
- 2. On August 25, 2011, an agent of the Enforcement Bureau's San Diego Office inspected the KKNS main studio located in Albuquerque, New Mexico, and observed the following violations:
 - a. 47 C.F.R. § 11.35(a): "EAS Participants must determine the cause of any failure to receive the required tests or activations specified in Sections 11.61(a)(1) and (a)(2). Appropriate entries indicating reasons why any tests were not received must be made in the broadcast station log as specified in Sections 73.1820 and 73.1840 of this chapter for all broadcast streams" At the time of the inspection, there were no entries in KKNS's logs indicating why the required weekly and monthly tests had not been received or transmitted sporadically over the three months prior to the inspection.
 - b. 47 C.F.R. § 11.61(a): "EAS Participants shall conduct tests at regular intervals, as specified in paragraphs (a)(1) and (a)(2) of this section. Additional tests may be performed anytime. EAS activations and special tests may be performed in lieu of required tests as specified in paragraph (a)(4) of this section. All tests will conform with the procedures in the EAS Operating Handbook." KKNS failed to ensure that, over the three months prior to the inspection, that all the required weekly and monthly tests of the

EAS system were received or transmitted over the three months prior to the inspection.

- 3. As the nation's emergency warning system, the Emergency Alert System is critical to public safety, and we recognize the vital role that broadcasters play in ensuring its success. The Commission takes seriously any violations of the Rules implementing the EAS and expects full compliance from its regulatees. Pursuant to Section 403 of the Communications Act of 1934, as amended,³ and Section 1.89 of the Commission's Rules, we seek additional information concerning the violations and any remedial actions the station may have taken. Therefore, El Camino must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response (i) must fully explain each violation, including all relevant surrounding facts and circumstances, (ii) must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and (iii) must include a time line for completion of any pending corrective action(s). The response must be complete in itself and must not be abbreviated by reference to other communications or answers to other notices.⁴
- 4. In accordance with Section 1.16 of the Commission's Rules, we direct El Camino, to support its response to this Notice with an affidavit or declaration under penalty of perjury, signed and dated by an authorized officer of El Camino, with personal knowledge of the representations provided in El Camino's response, verifying the truth and accuracy of the information therein,⁵ and confirming that all of the information requested by this Notice which is in the licensee's possession, custody, control, or knowledge has been produced. To knowingly and willfully make any false statement or conceal any material fact in reply to this Notice is punishable by fine or imprisonment under Title 18 of the U.S. Code.⁶
- 5. All replies and documentation sent in response to this Notice should be marked with the File No. and NOV No. specified above, and mailed to the following address:
