NOTICE OF VIOLATION

Released: September 23, 2011

By the District Director, Detroit Office, Northeast Region, Enforcement Bureau:

- 1. This is a Notice of Violation ("Notice") issued pursuant to section 1.89 of the Commission's Rules¹ to Krieger Communications Limited Liability Company ("Krieger Communications"), owner of antenna structure number 1207860 in Cuyahoga Falls, Ohio.
- 2. On September 6, 2011, an agent from the Commission's Detroit Office inspected antenna structure number 1207860, located at 2696 State Road, Cuyahoga Falls, Ohio (coordinates 41-08-44.2 North Latitude / 081-30-38.4 West Longitude). The agent observed the following violation:
 - 47 C.F.R. § 17.4(g): "The Antenna Structure Registration Number must be displayed in a conspicuous place so that it is readily visible near the base of the antenna structure. Materials used to display the Antenna Structure Registration Number must be weather-resistant and of sufficient size to be easily seen at the base of the antenna structure." At the time of the inspection, the Antenna Structure Registration Number was not posted.
- 3. Pursuant to section 403 of the Communications Act of 1934, as amended,² and section 1.89 of the Commission's Rules, Krieger Communications must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response must fully explain each violation, must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and should include a time line for completion of pending corrective action(s). The response must be complete in itself and signed by an authorized representative of Krieger Communications. All replies and documentation sent in response to this Notice should be marked with the File
