## Emergency Access Advisory Committee (EAAC) MINUTES September 9, 2011

Welcome and introductions were made and attendance was called for by EAAC Co-Chair David Dzumba and Cheryl King. A list of the attendees is attached to these minutes as APPENDIX A. The Agenda for this meeting is attached as APPENDIX B. The minutes of the August 12, 2011 meeting were approved.

Karen Strauss gave an update on Twenty-First Century Communications and Video Accessibility Act (CVAA) proceedings and other CVAA activities of interest to the EAAC at the FCC. Karen reported on ongoing rulemakings of possible interest to advocates and consumers with disabilities as well as industry partners. Patrick Donovan reminded the EAAC that a Notice of Proposed Rulemaking (NPRM) on NG911 issues is expected to be adopted at the September 22, 2011 open Commission meeting.
