If a licensee does not file the Required Notification or Extension of Time request, the Bureau presumes that the license or license component has not been constructed. Licensees that did meet their construction requirement have 30 days from the date of this Public Notice to file a petition for reconsideration showing that they have timely met the construction deadline.

In filing a petition for reconsideration, the licensee must include the actual date when construction was completed. Petitions for reconsideration may be filed electronically through ULS or by paper through the Office of the Secretary. To file electronically, visit the ULS web site at http://wireless.fcc.gov/uls/ and click on the "Submit a Pleading" link, complete the administrative information, and upload your petition for reconsideration. If filing by paper, the petitions for reconsideration should be directed to the Public Safety and Homeland Security Bureau and should further include, on the first page, the license Call Sign, Radio Service, and name of the Licensing Division reviewing the petition.
