**NOTICE OF VIOLATION**

Released: **November 10, 2011**

By the District Director, New York District Office, Northeast Region, Enforcement Bureau:

1. This is a Notice of Violation ("Notice") issued pursuant to section 1.89 of the Commission's rules<sup>1</sup> to Mobilitie Investments II, LLC, registrant of antenna structure # 1274485 in South Plainfield, New Jersey.
2. On October 20, 2011, an agent of the Enforcement Bureau's New York Office inspected antenna structure # 1274485, located at Inman Lumber Yard, South Plainfield, New Jersey, and observed the following violation:

47 C.F.R. § 17.4(g): "The Antenna Structure Registration Number must be displayed in a conspicuous place so that it is readily visible near the base of the antenna structure. Materials used to display the Antenna Structure Registration Number must be weather-resistant and of sufficient size to be easily seen at the base of the antenna structure." At the time of inspection, the agent observed that the Antenna Structure Registration Number was not posted at the base of the antenna structure.
3. Pursuant to section 403 of the Communications Act of 1934, as amended,<sup>2</sup> and section 1.89 of the Commission's rules, Mobilitie Investments II, LLC, must submit a written statement concerning this matter within 20 days of release of this Notice. The response must fully explain each violation, must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and should include a time line for completion of pending corrective action(s). The response must be complete in itself and signed by a principal or officer of Mobilitie Investments II, LLC. All replies and documentation sent in response to this Notice should be marked with the File No. and NOV No. specified above, and mailed to the following address:

Any false statement made knowingly and willfully in reply to this Notice is punishable by fine or imprisonment under Title 18 of the U.S. Code.<sup>4</sup>
