Re: Applications of AT&T Mobility Spectrum LLC and QUALCOMM Inc. for Consent
To Assign Lower 700 MHz Band Licenses (WT Docket No. 11-18)

Dear Messrs. Goggin and Brenner:

On August 8, 2011, we stopped the Commission's informal 180-day clock for review of the above-entitled transaction.¹ We noted that the Commission had been evaluating the relationship between this proposed transaction and AT&T's proposed acquisition of T-Mobile USA.² We concluded that the best way to determine whether either or both of the proposed transactions served the public interest was to consider them in a coordinated manner, without prejudice to independent treatment at a later date.

On November 29, 2011, we granted the request of AT&T Inc. and Deutsche Telekom AG to withdraw their applications to transfer control of the T-Mobile USA licenses and authorizations to AT&T.³ In light of that action, we now find it appropriate to restart the informal 180-day clock for the review of the above-entitled transaction, as requested in your letter of December 5, 2011.⁴ We will restart the clock as of November 29, 2011, the date the withdrawal was granted.
