NOTICE OF VIOLATION

Released: January 11, 2012

By the District Director, Denver Office, Western Region, Enforcement Bureau:

- 1. This is a Notice of Violation ("Notice") issued pursuant to Section 1.89 of the Commission's Rules, to Freisland Broadcasting Corp. ("Freisland"), licensee of radio station KRAN, Warren Air Force Base, Wyoming. This Notice may be combined with a further action, if further action is warranted.²
- 2. On August 15, 2011, an agent of the Enforcement Bureau's Denver Office inspected the KRAN main studio located in Cheyenne, WY, and observed the following violation:
 - a. 47 C.F.R. § 11.35(a): "EAS Participants must determine the cause of any failure to receive the required tests or activations specified in Sections 11.61(a)(1) and (a)(2). Appropriate entries indicating reasons why any tests were not received must be made in the broadcast station log as specified in Sections 73.1820 and 73.1840 of this chapter for all broadcast streams" At the time of the inspection, there were no entries in the station's logs indicating why KRAN did not receive a Required Weekly Test from KUWR, an assigned monitoring source, during the week of July 10-16, 2011.
- 3. As the nation's emergency warning system, the Emergency Alert System is critical to public safety, and we recognize the vital role that broadcasters play in ensuring its success. The Commission takes seriously any violations of the Rules implementing the EAS and expects full compliance from its regulatees. Pursuant to Section 403 of the Communications Act of 1934, as

amended,³ and Section 1.89 of the Commission's Rules, we seek additional information concerning the violations and any remedial actions the station may have taken. Therefore, Freisland must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response (i) must fully explain each violation, including all relevant surrounding facts and circumstances, (ii) must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and (iii) must include a time line for completion of any pending corrective action(s). The response must be complete in itself and must not be abbreviated by reference to other communications or answers to other notices.⁴

- 4. In accordance with Section 1.16 of the Commission's Rules, we direct Freisland to support its response to this Notice with an affidavit or declaration under penalty of perjury, signed and dated by an authorized officer of Freisland with personal knowledge of the representations provided in Freisland's response, verifying the truth and accuracy of the information therein,⁵ and confirming that all of the information requested by this Notice which is in the licensee's possession, custody, control, or knowledge has been produced. To knowingly and willfully make any false statement or conceal any material fact in reply to this Notice is punishable by fine or imprisonment under Title 18 of the U.S. Code.⁶
