## **Streamlined International Applications Accepted For Filing**

### **Section 214 Applications (47 C.F.R. § 63.18); Section 310(B)(4) Requests**

Unless otherwise specified, the following procedures apply to the applications listed below:

The international Section 214 applications listed below have been found, upon initial review, to be acceptable for filing and subject to the streamlined processing procedures set forth in Section 63.12 of the Commission's rules, 47 C.F.R. § 63.12. These applications are for authority under Section 214 of the Communications Act, 47 U.S.C. § 214, (a) to transfer control of an authorized carrier or to assign a carrier's existing authorization; and/or (b) to become a facilities-based international common carrier; and/or (c) to become a resale-based international common carrier.

Pursuant to Section 63.12 of the rules, these Section 214 applications will be granted 14 days after the date of this public notice (see 47 C.F.R. § 1.4 regarding computation of time), and the applicant may commence operations on the 15th day, unless the Commission has informed the applicant in writing, within 14 days after the date of this public notice, that the application, on further examination, has been deemed ineligible for streamlined processing.

Communications between outside parties and Commission staff concerning these applications are permitted subject to the Commission's rules for "permit-but-disclose proceedings." See 47 C.F.R. § 1.1206. An application can be removed from streamlined processing only in the sound discretion of Commission staff. The filing of comments or a petition to deny will not necessarily result in an application being deemed ineligible for streamlined processing.

The petitions for declaratory ruling listed below are for authority under Section 310(b)(4) of the Communications Act, 47 U.S.C. § 310(b)(4), to exceed the 25 percent foreign ownership benchmark applicable to common carrier radio licensees. The requested rulings will be granted 14 days after the date of this public notice, effective the next day, unless the application is formally opposed or the Commission has informed the applicant in writing, within 14 days of the date of this public notice, that the application, on further examination, has been deemed ineligible for streamlined processing. For this purpose, a formal opposition shall be sufficient only if it is received by the Commission and by the applicant within 14 days of the date of this public notice and its caption and text make it unmistakably clear that it is intended to be a formal opposition.

**Current Licensee:** Sage Telecom, Inc.

**FROM:** SP Sage LLC

**TO:** TSC Acquisition Corporation

Application filed for consent to the transfer of control of international section 214 authorization, ITC-214-19980415-00257 (Old File No. ITC-98-304), held by Sage Telecom, Inc. (Sage), from its 100% parent SP Sage LLC (SP Sage) to TSC Acquisition Corporation (TSC Acquisition). Pursuant a Stock Purchase Agreement, TSC Acquisition will purchase all of the outstanding stock of Sage from SP Sage.

GP/T Holdings, LLC (GP/T Holdings) has a 57% interest in TSC Acquisition and Gemini Partners, Inc. (Gemini) a 17% ownership interest. Matthew Johnson (M. Johnson) and Nathan Johnson (N. Johnson), both U.S. citizens, each have a 45% ownership interest in, and share control of, GP/T Holdings. M. Johnson and N. Johnson also each hold 50% ownership interest in, and share control of, Gemini. No other individual or entity holds a ten percent or greater direct or indirect equity or voting interest in TSC Acquisition or Sage.

Sage Telecom of Texas, LP (Sage-TX), a wholly owned subsidiary of Sage, provides international services under the international section 214 authorization held by Sage, ITC-214-19980415-00257, pursuant to section 63.21(h) of the Commission's rules, 47 C.F.R. § 63.21(h).
