NOTICE OF VIOLATION

By the Resident Agent, Miami Office, South Central Region, Enforcement Bureau:

- 1. This is a Notice of Violation (Notice) issued pursuant to Section 1.89 of the Commission's rules, to State of Florida, registrant of antenna structure numbers 1058422 and 1238242 in Miles City, Florida.
- 2. On June 28, 2012, an agent of the Enforcement Bureau's Miami Office inspected the site for the antenna structures located in Miles City, Florida and observed the following violations:
 - a. 47 C.F.R. § 17.4(g): "The Antenna Structure Registration Number must be displayed in a conspicuous place so that it is readily visible near the base of the antenna structure. Materials used to display the Antenna Structure Registration Number must be weather-resistant and of sufficient size to be easily seen at the base of the antenna structure." At the time of inspection, the Antenna Structure Registration Number was not readily visible at or near the base of antenna structure number 1238242.
 - b. 47 C.F.R. § 17.57: "The owner of an antenna structure for which an Antenna Structure Registration Number has been obtained must notify the Commission within 24 hours of completion of construction (FCC Form 854–R) and/or dismantlement (FCC Form 854). The owner must also immediately notify the Commission using FCC Form 854 upon any change in structure height or change in ownership information." The Commission's Antenna Structure Registration database shows the status of antenna structure number 1058422 as "constructed," but a State of

The response must be complete in itself and signed by a principal or officer of State of Florida.
