

I appreciate efforts by the FCC to reduce waste, fraud, and abuse in programs under the purview of the commission. As the FCC reviews these docket numbers, I respectfully ask that, in the process of implementing any potential changes, those who depend upon video captioning not be adversely affected. The Video Relay Service (VRS) is often the only form of communication for many hearing impaired Americans. Allowing for fair competition of choice and easy-to-use access by the end users of this service should be maintained. I would appreciate the FCC working with the deaf and hearing impaired community before any VRS changes are made. It is important that we do not potentially disrupt the video captioning service for those that depend upon it and not stifle future innovation.
