#### STATEMENT OF COMMISSIONER AJIT PAI ON WRDN, REEL COUNTRY 1430 AM

Durand, Wisconsin is a small town of about 1,900 people. Set on the banks of the Chippewa River, Durand is about 200 miles northwest of Madison, 80 miles southeast of Minneapolis, and 30 miles west of Eau Claire, a straight shot along Wisconsin Trunk 85. I've never been to Durand (although I hope to go someday), but I know many towns like it, including the one where I grew up. In places like Durand, a local radio station is an important way—sometimes one of the only ways—for folks to feel like they really are a part of the community.

On May 13, 2013, I had the pleasure of meeting Brian Winnekins of Durand. Brian and his wife Karla own and operate WRDN, Reel Country 1430 AM. Brian talked to me about the invaluable service WRDN provides to people in and around Durand and about some of the problems his station faces.

Brian also gave me a folder full of letters. The first letter described some of his ideas for improving the AM band. The rest of the letters were from citizens of Durand and nearby Arkansaw. They mentioned how grateful they were to Brian and Karla for buying the license to WRDN and bringing it back on the air in 2012, after five years of radio silence. They discussed how much they appreciated having radio coverage of local events like high school sports (WRDN is the home of the Durand Panthers). And several noted that WRDN helped local residents who were elderly or physically impaired stay informed about goings on around town, such as church services and weather updates.

These letters had a strong impact on me. With Brian's permission, and after making redactions of certain personal information, I've posted the letters along with this statement so that you can read them too. It's no secret that I'm a fan of AM radio. And it's no revelation that I'd like the Federal Communications Commission to start an initiative to revitalize the AM band. I hope that the words of these Wisconsinites, along with the everyday hard work of AM operators like Brian and Karla Winnekins, help illustrate why it's important for us to do so. There are so many people in the Durands of America who could benefit from that effort.


Dear Commissioner Pai.

Thank you for meeting with me and discussing issues facing the AM Radio band. As we discussed, my wife and I are co-owners of WRDN-AM in Durand, WI. Our station serves the County Seats of Pepin, Buffalo and Wabasha Counties with local radio. This station had been effectively off the air for 5 years before we put it back on air in April of 2012. Had my wife and I not purchased the license and put the station back on the air, Durand, Mondovi, Alma would all have NO local radio service. We strive to serve our local community, and I have included some letters from area residents and leaders about why our small AM station is important to the area.

My wife and I would like to personally thank you for your concern about revitalizing the AM Band. Recently at the NAB Conference in Las Vegas, you held a discussion about how to help revitalize the AM Band. There are many different ideas, but many will cost small broadcasters like myself too much money to implement. Here are some of the ideas...

- 1. Let AM Stations broadcast on FM translators. This has been going on, but only on existing translators. Since there is no available FM translator in Durand, I can't do this unless I purchase one and then "Hop" it-making small moves toward Durand until I can use it. Im not allowed to just move it to Durand all at once. Each one of these "Hops" costs money in engineering and FCC fees and could take years to complete.
- 2. Digital AM. This is coming from Ibquity Corporation. We would have to pay them for the technology(every year) and would have to totally replace all our transmitting equipment. Since most people don't have radios that receive digital AM, this is not very feasible.
- 3. Expand the FM band and put AM stations on that new band. Again, radio's can't receive these new frequencies so there would be that time lag, and I would be forced to totally replace all our transmitting and antenna equipment.





It is my belief, the EASIEST thing the FCC could do is the following:

- A. Start enforcing the part 15 interference rules. TV's, Computer Monitors, florescent lights, overhead electric lines and other consumer products are NOT ALLOWED to cause interference. The FCC has been pretty lax in enforcing that. Want to get rid of all the buzzing, etc..lets clean that up first.
- B. Let the AM broadcasters broadcast again with high bandwidth. Right now the NRCS rule prohibits us from anything over 9khz bandwidth. Factor that with radios that only allow 3khz to be received...and that is why AM sounds like a phone call! AM used to sound MUCH BETTER!!
- C. This will be the most controversial among radio engineers. Get rid of the 1930's rules forcing many AM stations to lower power at night. This rule was started because at night AM can go farther via Skywave. In 1930 it might have been important to have large regional stations serving a large rural area and small stations like us had to "clear the channel", but that is not the case any longer. Our station must lower power at night to "protect" a station in St. Louis, MO. While I like oldies, our biggest complaints are that at night people in Durand can't get us..instead they hear this station in St. Louis. They ask me why, I tell them I have to lower power and they all say..well thats just silly..we don't care about St. Louis and they don't careabout us! I believe that all stations should be allowed to be at 2,000 watts, and if they have a higher night power level, thats fine they can keep that. Many radio engineers will say it will cause more interference, but that would only happen in the fringe areas...in our case..areas to our south and for St. Louis areas to their north...but for both of us, those areas are OUT of our local listening area. I wouldn't jam St. Louis, or Mankato, MN or Beaver Dam, WI and they wouldn't jam me because we would all be at a higher power and would cancel each other out outside of our local areas. Again this might be true from a technical standpoint, but in reality our listeners don't care about technicalities..they just know they can't get us, so they don't listen. There are many local stations across the country that would do local sports, etc but figure its not worth it when people can't hear the signal. My suggestion is this..the FCC issue a temporary rule allowing all stations that have low night power, to increase it to their daytime power level to a max of 2,000 watts. Stations that already have a higher power at night can keep it. Do this from September 1-March 31 as a test to see how bad it would really be. Let all the broadcasters know so we can plan on

having local programming at night(i.e. high schools sports). Im betting that this would work just fine and the FCC could just leave the rule in place. If there is an issue with a station causing unacceptable interferance, it would be as simple as having the station then lower power to a point where the interferance is gone. By allowing this, it would help small broadcasters without a huge investment, we could use what we are currently using for transmitting equipment, our local listeners would benefit with local programming AND the business sponsors would benefit too! Of course this WONT help revitilize the AM Band if broadcasters continue to ignore their local communities and only have programming that is cheap and easy to air, but provides nothing to their communities. I'm not sure how the FCC could enforce having stations with "local" programing other than through the public service portion of a broadcast license.

Commissioner Pai, I would like to invite you to visit us in Durand some time and we can show you our station and how we serve our community and what its like to try and receive the station at night. I would also like to thank you again for meeting with me. It is not often that high level Government Officials are willing to take some of their valuable time to meet with the average citizen. Again it is a testimate to your commitment to all broadcasters large and small that you were willing to meet with me. I would also like to say thank you to the rest of the FCC staff that has helped us with license renewal and other questions that we have had. You and your staff are an example of how Government should work! Thanks again! If you have any questions, feel free to drop me an email or give me a call.

#### Dear Commissioner Pai,

My name is Robert Pelke. I own Prime Realty here in Durand, WI. I'm writing this letter on behalf of Karla and Brian Winnekins, owners of our local radio station, WRDN in Durand. I'm a lifelong resident of the Durand area, and I remember when both our radio stations left town about 6 years ago. The prior owner of the stations felt it was more important to serve the city of Menomonie, north of Durand. It was a very huge loss for our community, as we lost any coverage of local news, weather and sports. There were always discussions among area residents about what happened to the radio stations and why did they first move and then go off the air, and how it would be nice if there was a way to get the stations back.

In 2012, I was very excited to learn that Brian and Karla had purchased the license for the AM station here in Durand. I was so happy when the station went back on air in April of 2012, even though it was at a very low power from downtown Durand. I met with Karla and Brian and found out that the reason for the low power was because they were dealing with zoning issues for a new tower in Pepin County. I also learned that the FM station had been moved to Baldwin, WI and was never to return to Durand, and that if Karla and Brian had not purchased the AM license, it would have been very possible that Durand would have lost the AM station too.

Right away, Karla and Brian started making a difference. They had local news and local weather and even local obitituaries on air. They broadcasted from our local events like Durand Fun Fest and the Pepin County Fair, all while they both worked a 2<sup>nd</sup> job to keep the station going. They hired a student to help with news and sales, and I was very happy to become a sponsor on the station. When the weather was bad, Brian was on the air telling us about it. In the fall, they were broadcasting our local high school team's sporting events. What a thrill it was for our city to once again enjoy listening to play by play of football, and boys and girls basketball. Our football team went undefeated during the regular season, and residents who could not go to the games were able to hear the exciting play by play, even if we had to also hear a station in St. Louis, MO at the same time. Since the station was at a low power, everyone believed that would change once Karla and Brian had the "big boy tower" working.

This February, Karla and Brian announced they had been able to purchase the old tower south of town and were going to start using it! That meant the coverage would drastically increase and during the day it did. But at night, many can still hear St. Louis. Some nights it is very bad. I asked Brian about this, and he told me that the station had to lower power at night because the station had to "protect" St. Louis. He told me of how many AM stations have had to do that since the 1930's so the bigger stations can keep their large coverage areas. He said he wished the station could just stay at its daytime power, as that would give everyone the opportunity to still listen to the station, but since AM can skip across the atomosphere at night, the FCC prohibited him from being at a higher power. He also told me that the rule really didn't make sense since there was so much new man made interferance, that even if he was at the daytime power, he wouldn't affect the St. Louis station.

When Brian told me that he was going to meet you, he asked if I would write a letter of support, and I said yes without hesitation. I totally support what Karla and Brian are doing in Durand and how they have brought local radio back to our community. Brian tells me that you support AM radio and stations like WRDN, and for that I thank you. Brian also told me of his suggestion to help the smaller

stations right now, by letting them stay at their daytime power and trying this as a test this upcoming school year. I totally support this idea, because while I have nothing against St. Louis, their station doesn't care about Durand as well as it shouldn't, but there should be no reason why our station can't stay at its daytime power especially since Brian tells me that St. Louis would still have a higher power than WRDN so the only loss for St. Louis would be places like Durand. I know there are some techincal issues, but the reality here is for many of our residents, they can't hear the station very well at night, and that is a shame.

Commissioner Pai, we are very lucky to have our local radio station back, and myself and other residents are very protective of it. Before Karla and Brian put WRDN back on the air I had not listened to AM radio for years! I want to see it succeed just like I believe you do too. Please help our station and other stations like it by allowing this very affordable way to allow the smaller station owners and their communities a chance to succeed with decent night time service. If you would like to talk with me further, please give me a call anytime at a visit! Thank you again for your time reading this and for meeting with Brian.

They cover the Durand High School's sporting events for the seniors who can't drive at night or are "shut-ins."

WRDN has provided us with ways of reaching not only listening audience for the Fire Dept., but also to get things that we wouldn't normally have access too. For example, on May 11, we are celebrating our 125<sup>th</sup> year of service to the Durand area. WRDN was able to bring in a nationally known polka band to perform at our event. This has generated a tremendous amount of excitement not just within the area of Durand but throughout Western Wisconsin, which will only make our event more successful. Without WRDN this would not have been possible. Also, being a local funeral home owner, WRDN provides another outlet for families to let people know that someone they love has died and when the funeral arrangements are.

Having a *local station with local owners*, makes emergency situations or severe weather made known to people at anytime. But at night it can be hard to get information out because AM radio stations have to turn down there power at night. A simple and cost effective solution is to allow the AM radio stations to keep operating at full power 24 hours a day, 7 days a week.

I hope that you are able to see how important out station is to us and that we want WRDN to not only stay on the air, but be successful as well.

Brian is frequently in school looking to interview someone in the school system to help us promote the great things that we are doing. This is a relationship that has helped us pass a referendum this year and inforr the community of the great things happening in the school.

This year at Durand we were very fortunate to have very successful athletic teams. With that success comes many long drives as we progressed through the tournament run. As a result some of our most loyal fans could not make the trek to the far reaches of Wisconsin. They often relied on Brian to provide that visual for the action of our Panthers. I'm writing as a lifelong resident of the city of Durand. Our small town of 2,000 people has recently been blessed by the rejuvenation of our old radio station, AM 1430 WRDN by Brian and Karla Winnekins. As a student currently pursuing a journalism degree, the hard work and time that the Winnekins spent getting this station back on the air presented a wonderful opportunity for me to learn, but also gave me a unique perspective on exactly what this radio station meant to the community it served.

It didn't take long for the community to realize what a tremendous asset this station was. Even in the first tenuous days of broadcasting, the staff experienced an outpouring of support for our effort and the services that we were providing. Brian said from the very start of his work in Durand that, "If we care about the community, the community will care about us." His passion convinced me to assist him in broadcasting high school sporting events, local happenings, and news that would benefit the citizens of our town, who typically find themselves forgotten in the media coverage originating from far off cities with larger markets. 
