Application for 325 (c) permit by Broadcast Company of the Americas, LLC ("BCA") to renew authorization to deliver programming to XEPRS-AM, Rosarito, BC. XEPRS-AM operates on 1090 kHz at 50kW non-directionally during the day and at 50kW with a three tower directional array at night.
