Dear Acting Chairwoman Clyburn:

I am writing to you regarding the current retransmission content dispute between Time Warner Cable (TWC) and CBS. I make no representation as to the merits of either the CBS or TWC position in this dispute, but I do seek to convey to the Federal Communications Commission (FCC) the adverse impact that this dispute is having on many of my constituents.

These are contractual discussions between private parties. I am hopeful that these negotiations will conclude very soon, however, I am concerned about reports of CBS blocking access to its internet-based video for TWC customers. This approach to block internet-based content is a new development from many prior retransmission content disputes. I would appreciate a review by the FCC of these reports of blocked access to internet-based content that infringe the ability of viewers to freely access the internet-based content of their choice.
