NOTICE OF VIOLATION

Released: October 31, 2013

By the Resident Agent, Portland Resident Agent Office, Western Region, Enforcement Bureau:

- 1. This is a Notice of Violation (Notice) issued pursuant to Section 1.89 of the Commission's rules (Rules)¹ to Doug Ward, operator of motor vessel George W., Call Sign WDG2521, in Vancouver, Washington. Pursuant to Section 1.89(a) of the Rules, issuance of this Notice does not preclude the Enforcement Bureau from further action if warranted, including issuing a Notice of Apparent Liability for Forfeiture for the violation noted herein.²
- 2. On October 26, 2013, in response to an interference complaint on Marine VHF Channel 16 from the United States Coast Guard Sector Columbia River, an agent of the Enforcement Bureau's Portland Office investigated and observed the following violation:
 - a. 47 C.F.R. § 80.89(a): "Stations must not engage in superfluous radio communications." There appeared to be an open microphone on the vessel operating on Channel 16, with no authorized purpose for the transmissions.
- 3. Pursuant to Section 308(b) of the Communications Act of 1934, as amended,³ and Section 1.89 of the Rules, we seek additional information concerning the violations and any remedial actions taken. Therefore, Doug Ward, must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response (i) must fully explain each violation, including all relevant surrounding facts and circumstances, (ii) must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and (iii) must include a time line for completion of any pending corrective action(s). The response must be complete in itself and must not be abbreviated by reference to other communications or answers to other notices.⁴

- 4. In accordance with Section 1.16 of the Rules, we direct Doug Ward to support its response to this Notice with an affidavit or declaration under penalty of perjury, signed and dated by Doug Ward with personal knowledge of the representations provided in the response, verifying the truth and accuracy of the information therein,⁵ and confirming that all of the information requested by this Notice which is in the licensee's possession, custody, control, or knowledge has been produced. To knowingly and willfully make any false statement or conceal any material fact in reply to this Notice is punishable by fine or imprisonment under Title 18 of the U.S. Code.⁶
- 5. All replies and documentation sent in response to this Notice should be marked with the File No. and NOV No. specified above, and mailed to the following address:

- 6. This Notice shall be sent to Doug Ward at his address of record.
