## NOTICE OF VIOLATION

Released: January 9, 2014

By the District Director, San Diego Office, Western Region, Enforcement Bureau:

- 1. This is a Notice of Violation (Notice) issued pursuant to Section 1.89 of the Commission's rules (Rules), <sup>1</sup> to Voice Ministries of Farmington, Inc. (Voice Ministries), licensee of radio station KLJH(FM) in Farmington, New Mexico. Pursuant to Section 1.89(a) of the Rules, issuance of this Notice does not preclude the Enforcement Bureau from further action if warranted, including issuing a Notice of Apparent Liability for Forfeiture for the violations noted herein.<sup>2</sup>
- 2. On November 18, 2013, an agent of the Enforcement Bureau's San Diego Office inspected radio station KLJH(FM)'s main studio located at Farmington, NM, and observed the following violations:
  - a) 47 C.F.R. § 11.35(a): "EAS Participants must determine the cause of any failure to receive the required tests or activations specified in §11.61(a)(1) and (2). Appropriate entries indicating reasons why any tests were not received must be made in the broadcast station log as specified in §§73.1820 and 73.1840 of this chapter for all broadcast streams ...." At the time of the inspection, there were no entries explaining why the required weekly and monthly tests were not received. The station logs failed to show explanations by the Chief Operator for why these tests were not received and retransmitted.
  - b) 47 C.F.R. § 11.52(d)(1): "With respect to monitoring for EAS messages that are formatted in accordance with the EAS Protocol, EAS Participants must monitor two EAS sources. The monitoring assignments of each broadcast station and cable system and wireless cable system are specified in the State EAS Plan

and FCC Mapbook." On the day of inspection, KLJH's EAS equipment was not monitoring the correct monitoring assignments for the Bayfield, Colorado area.

- 3. As the nation's emergency warning system, the Emergency Alert System is critical to public safety, and we recognize the vital role that broadcasters play in ensuring its success. The Commission takes seriously any violations of the Rules implementing the EAS and expects full compliance from its regulatees.
- 4. Pursuant to Section 308(b) of the Communications Act of 1934, as amended,<sup>3</sup> and Section 1.89 of the Rules, we seek additional information concerning the violations and any remedial actions taken. Therefore, Voice Ministries, must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response (i) must fully explain each violation, including all relevant surrounding facts and circumstances, (ii) must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and (iii) must include a time line for completion of any pending corrective action(s). The response must be complete in itself and must not be abbreviated by reference to other communications or answers to other notices.<sup>4</sup>
- 5. In accordance with Section 1.16 of the Rules, we direct Voice Ministries to support its response to this Notice with an affidavit or declaration under penalty of perjury, signed and dated by an authorized officer of Voice Ministries, with personal knowledge of the representations provided in Voice Ministries' response, verifying the truth and accuracy of the information therein,<sup>5</sup> and confirming that all of the information requested by this Notice which is in the licensee's possession, custody, control, or knowledge has been produced. To knowingly and willfully make any false statement or conceal any material fact in reply to this Notice is punishable by fine or imprisonment under Title 18 of the U.S. Code.<sup>6</sup>
