Such objections must be filed with the Commission, and served on the incumbent LEC, no later than the ninth business day following the release of this public notice. *See* 47 C.F.R. § 51.333(c). The effective implementation date of these changes is subject to the FCC's 90-day public notice period under section 51.333(b). *See* 47 C.F.R. § 51.333(b).

Information service providers and telecommunications service providers that directly interconnect with the incumbent LEC's network may file objections, and other interested parties may file comments,

regarding this network change notice using the Internet by accessing the ECFS: http://apps.fcc.gov/ecfs. Filers should follow the instructions provided on the Web site for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. All information submitted including names and addresses will be publicly available via the web.

Documents shown or given to Commission staff during ex parte meetings are deemed to be written ex parte presentations and must be filed consistent with rule 1.1206(b).
