The SS7 linksets from the Beaumont Nortel DMS STPs (BUMTTXTEK01/BUMTTXTWK01) will need to be re-homed into the Dallas/Fort Worth, Texas Tekelec STPs (DLLSTXTA38W/FTWOTXED36W). Changes are scheduled to occur during the 4th quarter of 2015.	Beaumont, TX Dallas/Ft. Worth, TX
