Modification

Intelsat License LLC seeks to modify the authorization for the Intelsat 16 space station to specify operations at the 58.1° W.L. orbital location where it will provide fixed-satellite service in the 10.7-11.45 GHz (space-to-Earth), 11.7-12.2 GHz (space-to-Earth), 12.75-13.25 GHz (Earth-to-space), 13.75-14.0 GHz (Earth-to-space), and 14.0-14.5 GHz (Earth-to-space) frequency bands. Intelsat also seeks to conduct telemetry, tracking and command operations necessary to maintain Intelsat 16 at the 58.1° W.L. orbital location using the following center frequencies: 13997.5 MHz and 14499.5 MHz (Earth-to-space); and 12198.25 MHz and 12198.75 MHz (space-to-Earth). Intelsat requests waivers of Sections 25.164 and 25.165 of the Commission's rules in connection with this application.

Inmarsat plc has filed a Petition for Declaratory Ruling requesting that the Commission modify the ISAT list to add the Inmarsat-3 F5 satellite as a replacement for the Inmarsat-3 F4 satellite at the 54° W.L. orbital location as a permitted point of communication in the 1525-1559 MHz (space-to-Earth) and 1626.5-1660.5 MHz (Earth-to-space) frequency bands.
