The SS7 linksets from the Lubbock Nortel DMS STPs (LBCKTXPS07W/LBCKTXSW04W) will need to be re-homed into the Austin, TX Tekelec STPs (AUSTTXGR57W/AUSTTXTE13W). The new FSPOI codes are LBCKTXPS39W/LBCKTXSW08W. <b>Changes were originally scheduled to occur during the 2nd quarter of 2016.</b>	Austin, TX Lubbock, TX
