AT&T plans to decommission the STPs in the Lubbock, TX area and consolidate the STPs in LATA 544 into LATA 558. The SS7 linksets from the Lubbock Nortel DMS STPs (LBCKTXPS07W/LBCKTXSW04W) will need to be re-homed into the Austin, TX Tekelec STPs (AUSTTXGR57W/AUSTTXTE13W). The new FSPOI codes are LBCKTXPS39W/LBCKTXSW08W. Changes have been rescheduled to occur during the 3rd quarter of 2017.	Austin, TX Lubbock, TX

Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b).
