



Communications Status Report for Areas Impacted by Hurricane Irma September 13, 2017

The following is a report on the status of communications services in geographic areas impacted by Hurricane Irma as of September 13, 2017 at 11:00 AM EDT. This report incorporates network outage data submitted by communications providers to the Federal Communications Commission's Disaster Information Reporting System (DIRS). DIRS is currently activated for all areas of Florida, Puerto Rico, the U.S. Virgin Islands, and parts of Georgia and Alabama. Note that the operational status of communications services during a disaster may evolve rapidly, and this report represents a snapshot in time. It should also be noted that not all communications providers have reported in DIRS, so some outage information may not be complete.

The following counties are in the geographic area that was covered by the DIRS activation as of this morning (the "disaster area").

911 Services

The Public Safety and Homeland Security Bureau (PSHSB) learns the status of each Public Safety Answering Point (PSAP) through the filings of 911 Service Providers in DIRS, reporting to the FCC's Public Safety Support Center (PSSC), coordination with state 911 Administrators, and, if necessary, from individual PSAPs.

There are a total of 29 (same as yesterday) PSAPs affected in Florida, 5 (up from none yesterday) PSAPs affected in the reporting area in Georgia, and 2 (same as yesterday) PSAPs affected in the U.S. Virgin Islands.

- **Down with no re-routes:** 4 (Homestead Air Force, FL, Indian River EOC, FL, Marathon County SO, FL, and Ocean Reef, FL)
- **Up without ALI:** 9 (Cape Coral PD, FL, Collier County EOC, FL, Ft. Two PSAPs in the U.S. Virgin Islands (St. Croix 9-1-1 Call Center and St. Thomas 9-1-1 Call Center), are unable to retrieve Phase I and Phase II location information for wireless callers and Automatic Number Identification (ANI)//ALI for VoIP Callers.

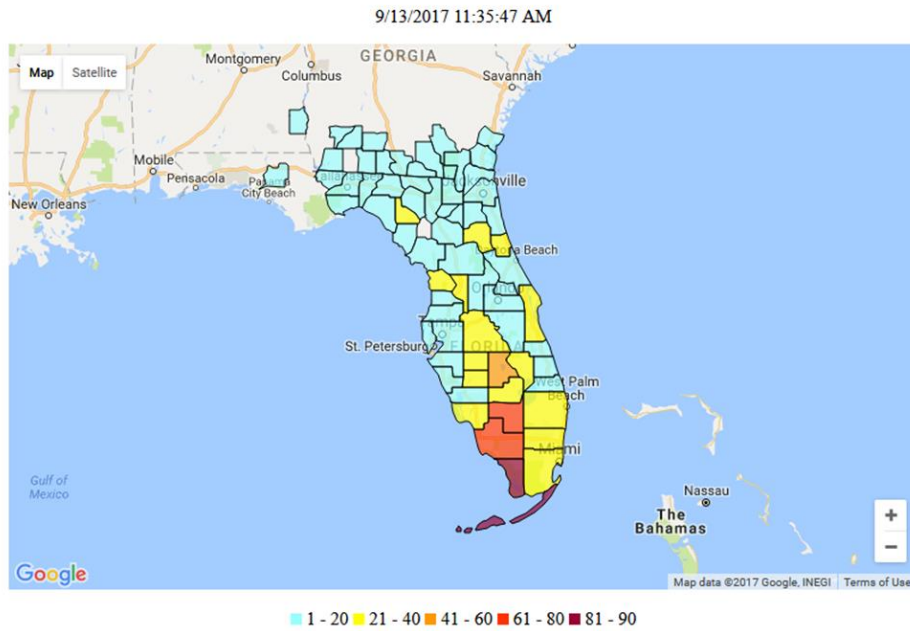
Wireless Services

The following maps of the disaster area illustrate which counties in Alabama, Florida, Georgia, and Puerto Rico are most affected:

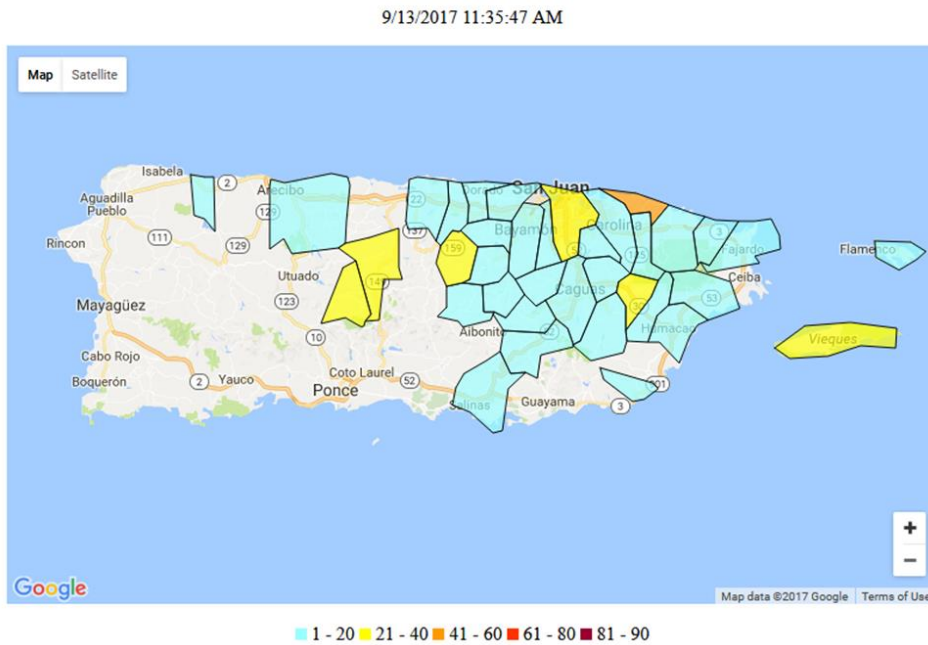
Alabama, Florida, and Georgia:

The information shown was provided by the signatories to the Wireless Resiliency Cooperative Framework and several additional companies that agreed to allow us to include their data in the aggregated data:

Alabama: Less than 1% of cell sites in the disaster area are out of service

Florida: 18.1% (down from 24.6% yesterday) of cell sites are out of service.

Georgia: Overall, 5.3% (down from 10.5% yesterday) of cell sites in the disaster area are out of service.

Puerto Rico: 10.1% (down from 14.5% yesterday) of cell sites are out of service.

Virgin Islands: 54.7% (up from 53.8%) of cell sites are out of service.

Cable Systems and Wireline (Combined)

There are at least 8,190,407 (up from 7,184,909 yesterday) subscribers out of service in the affected areas in Alabama, Florida, and Georgia. This includes users who get service from cable system or wireline providers. There are a total of 1,040 (up from 819 yesterday) non-mobile switching centers out in Alabama, Florida, and Georgia.



Since there are widespread power outages in Puerto Rico and the U.S. Virgin Islands, the FCC has received reports that large percentages of consumers are without either cable services or wireline service. Companies are actively working to restoring service.
