Subject: Notification of Copper Retirement Pursuant to 47 C.F.R. § 51.332
Date Effective: March 1, 2018

Network Change:

Frontier Communications announces that it is retiring copper feeder plant as part of a Highway Improvement plan impacting its Spencerport, New York Central Office (CLLI SPPTNYAN). The copper loops will be replaced with fiber to the home and impact a portion of the Spencerport Central Office service area.

Description of Reasonably Foreseeable Impact of the Planned Changes:

After the planned copper retirement, there will no longer be copper loop feeder facilities providing connectivity between Frontier’s Spencerport, NY Central Office and the customer premises locations listed below. Frontier is planning to replace the existing copper loops with fiber drops as part of this project.

After the planned network changes are implemented, Frontier will (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities.

Following the transition to fiber, customers can anticipate receiving services from Frontier that are equivalent to or better than those they received over copper facilities, and at that same prices.

In accordance with FCC Rule 47 C.F.R. §51.332(b)(2), all carriers that are currently interconnected at this Central Office location are being notified of the upgrade. In addition, all impacted retail customers are being notified in accordance with FCC Rule 47 C.F.R. §51.332(c)(2).
