Subject: Network Notification No. 111

Public Notice of Copper Retirement Under Rule 51.332

This Notice, pursuant to CFR 47, Subsections 51.325 – 51.335 advises of the following Network change(s) and/or improvement(s) within Northern New England Telephone Company of Maine LLC d/b/a FairPoint Communications and the scheduled implementation date.

**Maine Wire Centers:**

Dover Foxcroft, Maine (DVFXMEMA), Dover Foxcroft Remote Terminal DVFXMEDCOOW  
P 196 TS 289 XBOX State RTE 15, Bangor Road

**Planned Implementation or Retirement Date:** Will not be implemented for 180 days after the release of the Commission's public notice of filing.

**Description of Change:** After the planned network changes identified above are implemented, although copper (metallic) sub-loop facilities will remain in place between FairPoint's Remote Terminal identified above and customer premises in the affected area, access to such subloops (or a subset thereof) will no longer exist from the CLEC TOPIC in the area.

**Description of Foreseeable Impact:** Replacing copper pair with DLC (fiber). The circuits listed below are the existing UNE xDSL or Digital Design Loop (DDL) services that **will** be disconnected with this network change.

The following loop types will be transferred to new DLC systems:

2-Wire Analog Voice Grade Loop	4-Wire Analog Voice Grade Loop
2-Wire ISDN Digital Grade Loop	4-Wire 56 kbps Loop
DS1 Loop	

The UNE DSL loop types that require copper cable for provisioning will no longer be available from FairPoint's.

Any such UNE x ADSL metallic loops that are in service on the Implementation Date will be disconnected.



**Description of Changes to Rates, Terms & Conditions:** There will be no change to the Rates, Terms or Conditions for Telecommunications Services.

The following UNE loop types plus any services not specifically identified that require copper cable for provisioning will no longer be available from FairPoint's Dover Foxcroft, Central Office to customer premises in the affected area:

- 2-Wire ADSL - Compatible Loop
  - 4-Wire HDSL - Compatible Loop
  - 2-Wire SDSL - Compatible Loop
  - 2-Wire HDSL - Compatible Loop
  - 2-Wire IDSL - Compatible Metallic Loop
  - 2-Wire Digital Designed Metallic Loop
- Any such UNE xDSL or metallic loops that are in service on the Implementation Date will be disconnected by Fairpoint
